# RIGHTS IN YOUR HOME

## ✓ **You have the right to not open the door**

ICE does not have the right to enter your home without a **valid warrant signed by a judge**.

## ✓ **Keep Calm**

You have the right to **not provide any details about your immigration status**, your name or age. **Remember, do not lie!** You can exercise your right to **remain silent**. Everything you do or say can be used against you.

## ✓ **Make a family plan**

If you have children identify a caregiver.

## ✓ **You have the right to not sign**

Any documents without legal counsel present. If you do not speak English ask for an interpreter.

## ✓ **Record the moment**

**It's advised to take videos, pictures or notes of any interaction with ICE.** It can help verify an immigration raid and may help your case or someone else's.

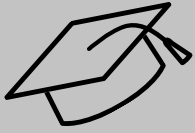

- ✓ You have the right to **stay silent** and to ask to speak with a trusted immigration attorney.
- ✓ If **ICE enters a private area**, you can say: "This is a private area. You cannot legally enter without a judicial warrant signed by a judge. **Do you have a judicial warrant?**".
- ✓ If your colleagues are willing, encourage them to **record or take photos during the interaction**.
- ✓ It can be helpful to have and practice a **rapid response plan with your co-workers**. Practice what to say, what to do.
- ✓ Ask your employer to **schedule a Know Your Right training** for all employees.
- ✓ **Identify an immigration response** network in your area.
- ✓ If **your employer asks to reverify your immigration status** as it relates to your employment, check to see if others are being asked as well. Ask for time to gather documents. Do not provide false documentation.

MOVEMENT

- ✓ **You have the right to speak out**, hand out flyers and petitions and wear expressive clothing in school - as long as they do not violate school policies.
- ✓ **Schools cannot discriminate** against students on the basis of race, color, or national origin.
- ✓ All students, regardless of their immigration status, **have the right to a free public education**.
- ✓ **Parents are not required** to provide their immigration status nor the immigration status of their children to enroll them in school.
- ✓ **Students with limited English proficiency** cannot be turned away by public schools.
- ✓ If ICE begins to search you, you have the right to say. If ICE begins to search you, clearly state: **"I do not consent to this search"**.

- ✓ **Consider granting a trusted person** power of attorney.
  - **Why do this?:** In case you are rendered unable, a power of attorney allows someone else to conduct essential legal functions on your behalf.
- ✓ Consider adding a trusted person to the list of people **authorized to pick up your children at school.**
- ✓ **Make a plan for someone to take care** of your dependents and pets.

## WHAT SHOULD MY PLAN INCLUDE?

It's highly encouraged for non-citizen parents to identify a trusted guardian to care for the wellbeing of their children. ## GATHER IMPORTANT DOCUMENTS AND HAVE MULTIPLE COPIES

**IF YOU SUSPECT AN IMMINENT ICE RAID, CONTACT YOUR ATTORNEY IMMEDIATELY AND FOLLOW YOUR FAMILY COMMUNICATION PLAN.**

## WHAT'S THE DIFFERENCE?

Administrative warrants or immigration warrants are issued by a federal agency such as DHS and can be signed by an "immigration judge" or an "immigration officer." **Unlike a judicial warrant, an administrative warrant does not authorize a search. See below for examples of both types of warrants.**

## WAYS TO SUPPORT UNDOCUMENTED STUDENTS AND THEIR FAMILIES:

### ✓ Educate

Educate students about their rights by **disseminating “know your rights” materials.**

### ✓ Provide

- **A safe place for students to wait** if a parent or sibling has been detained.
- **Counseling for students** who had a family member detained by ICE.

### ✓ Work with parents

To develop a family immigration raid emergency plan and identify a trusted individual to pick up your children from school.

### ✓ Work with your school board

To pass resolution affirming schools as welcoming places of learning for all.

### ✓ Identify

Someone at school who can serve as the immigration resource advocate in your building/campus.

### ✓ Issue

Statements condemning lawless raids and calling for the immediate release of students.

## BELOW, WHAT YOU HAVE THE RIGHT TO SAY AND DO:

- ✓ If stopped, ask ***"Am I free to go?"*** :
  - If YES, state ***"I do not want to answer your questions"*** or ***"I'd rather not speak with you right now"***. Walk away.
  - If NO, ask ***"Am I being detained?"***:
    - If no, clearly state ***"I do not want to answer your questions"*** or ***"I'd rather not speak with you right now"***. Walk away.
    - If yes, clearly state ***"I want to exercise my right to remain silent"*** and then say ***"I would like to speak to my immigration attorney"***
  
- ✓ If ICE has **probable cause**, they can search you. It needs to be within reason. Repeat: ***"I do not consent to this search"*** if you feel search is illegal.
  
- ✓ Remember:
  - You have the **right to remain silent**.
  - **Do not run, argue, or resist:** Even if you believe your rights are being violated , ICE can use this as reason to stop you and use excessive force.
  - Keep your hands visible.
  - **Don't lie** about your status or provide false documents.
  - Stay **calm**.

## ✓ To share

You have the right to **share truthful, lawfully obtained information** about law enforcement, including about what officers are doing and where they are doing it.

## ✓ To tell

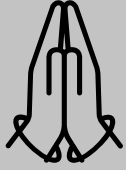
You have the right to tell people **about their legal rights**.

## ✓ Make a family plan

Even if the person who initially gathered the information broke the law in getting it, **you have the right to communicate the information as long as you aren't breaking any laws in getting or communicating it**—such as by trespassing or wiretapping.

## ✓ Can ICE enter places of worship?

ICE may enter public spaces in a place of worship; however, **they still need a judicial warrant in order to access private spaces.** Additionally, places of worship do not need to enforce immigration laws. Even if ICE agents enter your congregation, you are under no obligation to talk to them or answer their questions.

## ✓ What is a “private” vs “public” space?

**Whether an area of a church is public or private is going to depend its usage** and whether the church has a “reasonable expectation of privacy” in that area. For instance, a church lobby is likely public while a church office, that cannot be entered without a church employee, may be private.

## ✓ How can places of worship help immigrants?

**By providing Know Your Rights information and creating alliances with pro-immigrant organizations in their region.** It is also helpful to encourage congregants to stand in solidarity and push back against injustice and family separation.
